### Typical Inductance vs. Current Characteristics:



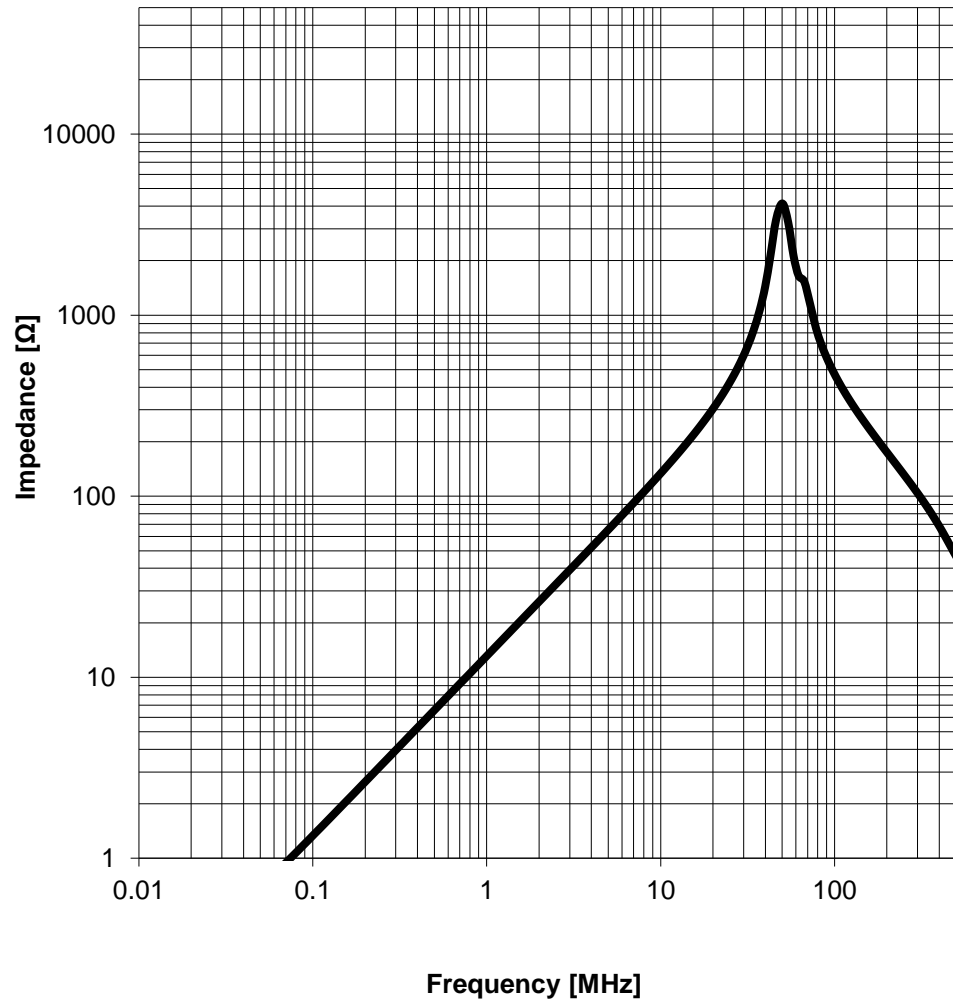
### Typical Temperature Rise vs. Current Characteristics:

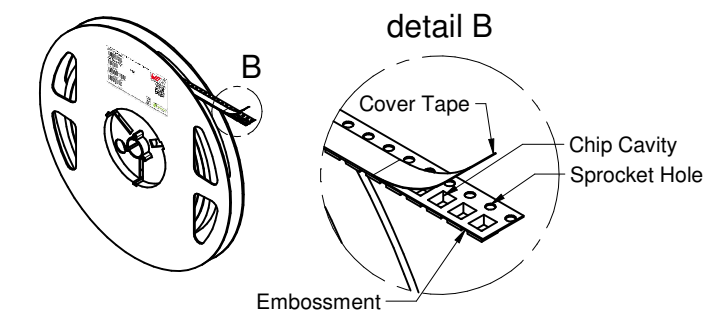
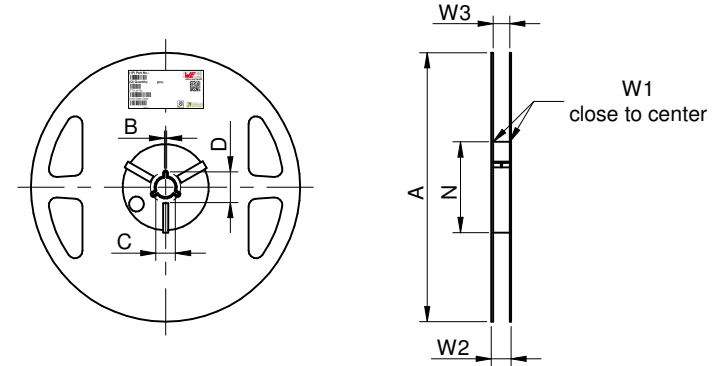
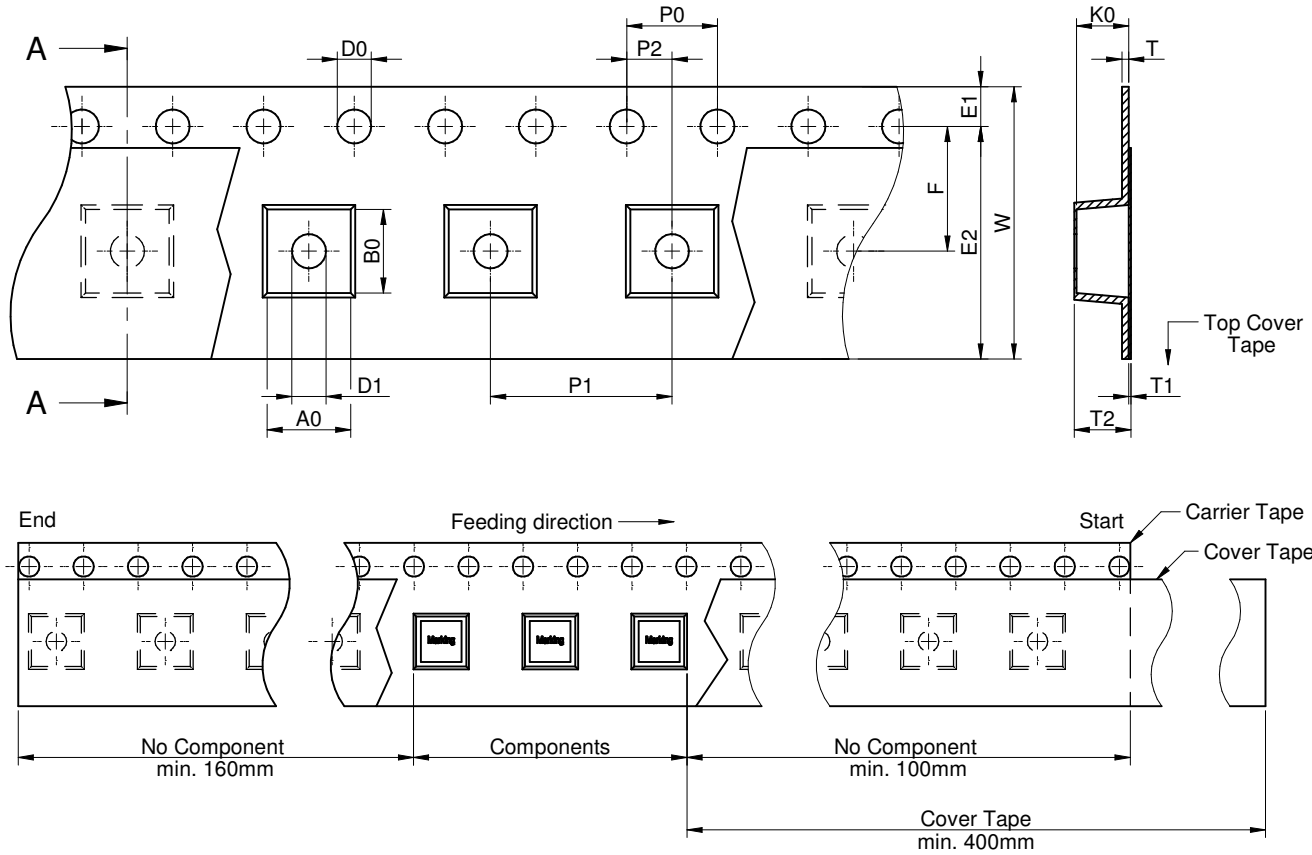

## Typical Impedance Characteristics:



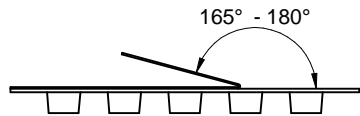

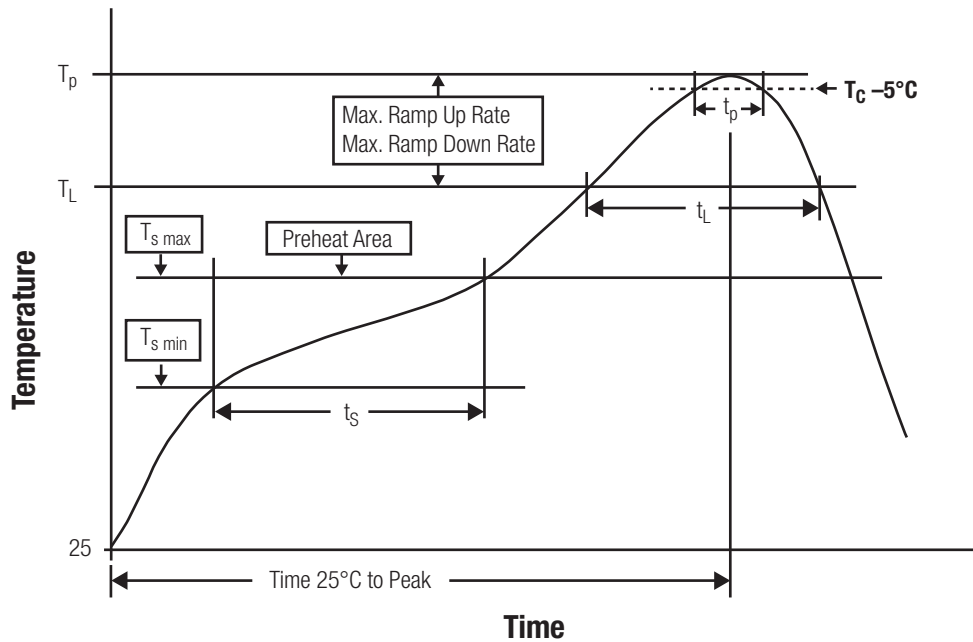


## Storage Conditions:


